Awaiting Results of Motion for Summary Judgment

On February 21, 2001, several residents attended our Motion for Summary Judgement (MSJ) hearing at the Circuit Court in Annapolis. Through our attorney, we asked the judge to uphold and enforce our 1938 Injunction on the clubhouse. The Injunction grants lot owners free and unobstructed use of our community property. The judge heard arguments from our attorney and the attorney for Youth Development Foundation (YDF). YDF, which has locked us out of the clubhouse, believes we do not have rights to the building, only rights to the land surrounding it.

As this article is being written (March 22, 2001), we have not yet heard the judge's decision. The judge is not under any time limit for rendering his decision, although we are assuming he will decide by our full trial date, which is April 11, 2001 at 9:00 AM at the Circuit Court in Annapolis. We will proceed with the full trial only if the judge does not rule in our favor for the Motion for Summary Judgement. At the full trial, we will be asking the judge to consider several other counts in addition to enforcing our Injunction.

The Selby Community Association will do its best to inform the community as quickly as possible of the outcome of the MSJ hearing and what our next step will be following the judge's decision.
