MEDIATION: SELBY VS. YDF

On March 11, 2003, several residents and our attorney, Harrison Wetherill, Jr., attended a scheduling conference before Judge Silkworth at the Circuit Court to address the preliminary injunction filed by YDF last October. Instead of scheduling a date for the preliminary injunction, both parties agreed to take part in mediation, with a court-appointed mediator, in order to discuss how we could amicably make joint use of the Clubhouse. The Court believes this case would be better served outside of the court room. The mediation took place on April 11, 2003. The mediator was a retired Circuit Court judge. In attendance for Selby were Ed Robey, Martin O'Callaghan, Evelyn Gingell, Susan Lanier and our attorney. In attendance for YDF were Mary Facella (Secretary/Treasurer), Mario Facella (President) and their attorney.

Just prior to the mediation YDF's attorney had sent a proposal of YDF's plans for use of the Clubhouse to the judge and our attorney. We had also sent a document listing all of the uses we make of the building. In summary, YDF's proposal stated plans to use the building for eventual year-round recreational and educational activities for the underprivileged youth they claim to serve, as well as corporate meetings, seminars, etc. They would also permit other related organizations to use the building for corporate and recreational purposes. The plans also calls for conversion of part of the Clubhouse into a dormitory area for extended over-night camping.

YDF stated that they would allow us unlimited access of the one restroom in the snack bar area only. In exchange for a lease agreement, we could have unlimited access to the snack bar area only. Any use of any other part of the building would be available under a lease agreement and fees.

It was apparent even before we got to mediation that we had very different ideas for sharing the building. They were not willing to discuss any changes to their plans and we were not willing to give up any of our rights. The easement covers the whole building, not just one bathroom. We were prepared to work out a plan of shared use, but we don't believe we should have to sign a lease and pay fees for a building for which we have an easement of free and unobstructed use.

Discussion moved on to the possibility of purchasing the Clubhouse. YDF said we should pay them what it would cost them to buy a comparable property with which they can carry out their plans. We believe we just need to pay them, at most, for what the property is actually worth on the market. Keep in mind that the Clubhouse was given to them.

Mediation ended with an agreement that the value of the property would be decided using a Court-proven method of using appraisals to justify the value of real estate.

Since then, we attended a second mediation and we have been negotiating a contract in order to carry out the appraisals and, ultimately, we hope, the purchase of the building and the lot it sits on. YDF owns two (2) lots on either side of the Clubhouse lot, but they are not willing to sell them at this time. The other two lots have not been part of the lawsuit.

A follow-up meeting with Judge Silkworth has been set for October 2003. If we are not able to agree on a contract, we will set a court date at this meeting for the preliminary injunction YDF has filed against us.

These recent rounds of mediation and negotiation have been costly. Quotes for an appraisal have been in the several thousands of dollars. It will be several months before we receive another allotment of money from our Special Community Benefit Tax account. Any donations toward our legal fees would be appreciated. Please send any donations to the address at the top of this newsletter.

We have been discussing financing concerning purchasing the Clubhouse with a local lender. Because we have a Special Community Benefit Tax District, they feel we will be an acceptable risk. When we have a signed contract with YDF and have determined a purchase price based on the appraisals, we will send a letter to all lot owners requesting support in using the Benefit District to acquire a loan. Included in the letter will be a proposed budget reflecting addition of the loan. We don't anticipate having to raise the tax very much, if at all.

We are working hard to bring an end to this legal battle over our community area.
