4. Event **MUST** conclude no later than **9:30 P.M.**, especially any disturbing level of music or noise.
5. Maintaining an acceptable volume level of music or noise so that I do not disturb neighbors.
6. Absolutely NO glass containers or devices that may endanger members or guests at the beach.
7. Pets are allowed in all areas except for swim areas and the beach – “**NO DOGS ON BEACH**”.
8. I **MUST** be present at the event and am responsible for the actions of my guests.
9. All fees related to checks written to SCA that are returned as NSF or “Insufficient Funds”.
10. No selling or trading of any product or service for profit/ gain allowed whatsoever.
11. Respect any/all requests made by SCA Security staff to maintain safety, order and peace.

I understand that if I do not abide by the rules noted above for using the community commons areas that I may lose my privileges to use these areas in the future for a period of time that may include up to a permanent loss of those privileges.

I understand that any violations of these rules and any other Federal, state and local laws may result in member(s)/ guest(s) being disbarred from an event and community property by SCA Security for remainder of the day and/or permanent loss of privilege to use the community commons area properties.
